

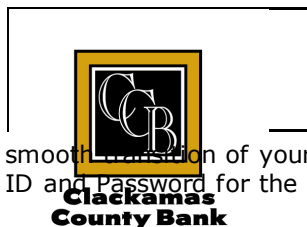

Introduction

As Clackamas County Bank completes its system conversion to, you will need to modify your Quicken settings to ensure the smooth transition of your data. To complete these instructions, you will need your Access ID and Password for the Clackamas County Bank website.

It is important that you perform the following instructions exactly as described and in the order presented. If you do not, your service may stop functioning properly. This conversion should take 15–30 minutes.

This update is time sensitive and can be completed on or after April 16, 2015.

Documentation and Procedures

Conversion Preparation

Backup your data file. For instructions to back up your data file, choose **Help** menu > **Search**. Search for *Backing Up Your Data* and follow the instructions.

Download the latest Quicken Update. For instructions to download an update, choose **Help** menu > **Search**. Search for *Update Software* and follow the instructions.

Connect to [Financial Institution A]

1. Log in to *Clackamas County Bank* and download your Quicken Web Connect file.
2. Click **File** > **File Import** > **Web Connect File**.
3. Repeat this step for each account (such as checking, savings, credit cards, and brokerage) that you use for online banking or investing.
4. If new transactions were received from your connection, accept all new transactions into the appropriate registers.

If you need assistance matching transactions, choose **Help menu** > **Quicken Help**. Search for **Matching Transactions** and follow the instructions.

Deactivate Your Account(s) At Clackamas County Bank

1. Choose **Tools** menu > **Account List**.

Click the **Edit** button of the account you want to deactivate.

In the **Account Details** dialog, click on the **Online Services** tab.

Click **Deactivate**. Follow the prompts to confirm the deactivation.

Click on the **General** tab.

Remove the financial institution name and account number. Click **OK** to close the window.

Repeat steps 2–6 for each account at Clackamas County Bank.

Re-activate Your Account(s) at Clackamas County Bank

1. Log in to Clackamas County Bank and download your Quicken Web Connect file.
2. Click **File** > **File Import** > **Web Connect File**.
3. If prompted for connectivity type, select **Web Connect**.

Take note of the date you last had a successful connection. If you have overlapping dates in the web-connect process, you may end up with duplicate transactions.

4. Ensure you associate the account to the appropriate account already listed in Quicken. You will want to select **Link to an existing account** and select the matching account in the drop-down menu.

Do **NOT** select **Create a new account**. If you are presented with accounts you do not want to track in this data file, select **Ignore – Don't Download into Quicken** or click the **Cancel** button.

5. Repeat steps 2 – 4 for all of your accounts.
